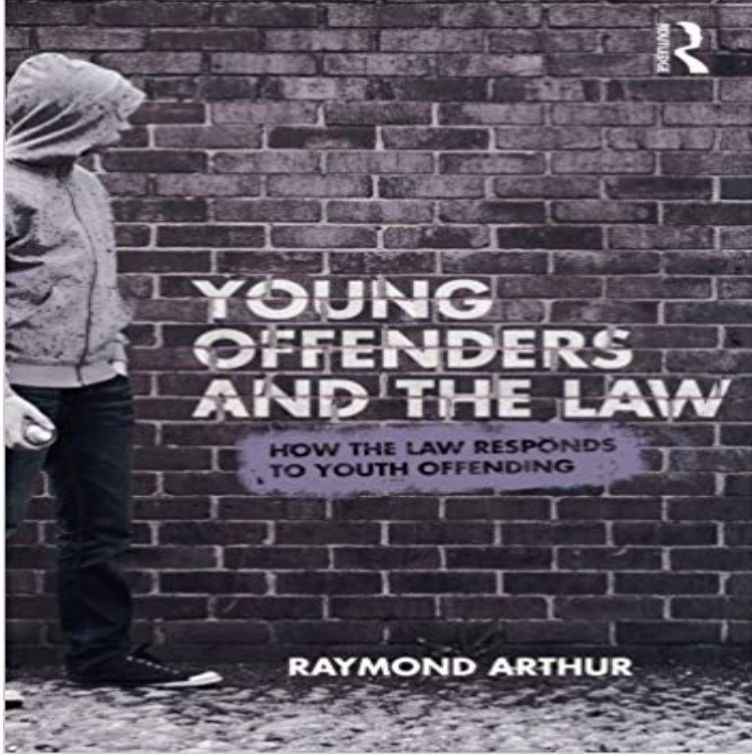


# Young Offenders and the Law: How the Law Responds to Youth Offending
