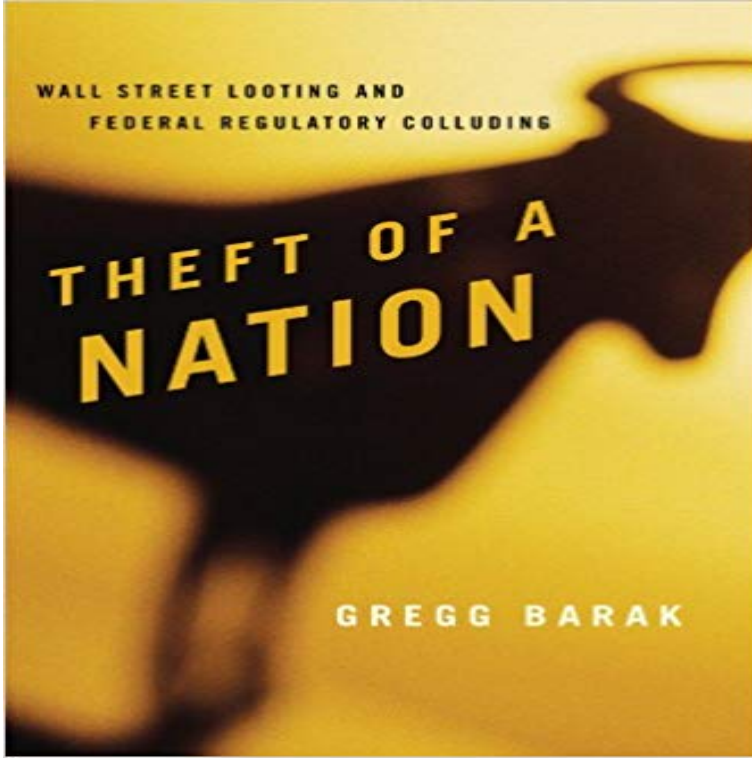


## Theft of a Nation: Wall Street Looting and Federal Regulatory Colluding (Issues in Crime and Justice)
